



## FREYSTROP COMMUNITY COUNCIL

### Minutes of the meeting held on Monday 10 November 2025 in the Village Hall at 19:00

1. Opening Remarks
  - The Chair apologised for his late arrival and the delay to the start of the meeting
2. Attendance & Apologies
  - Please refer to attached register
3. Declarations of Interest
  - The declaration of interests form must be completed, signed and returned to the clerk prior to any discussion on the related matter
4. Minutes of the 13 October Monthly Meeting
  - Draft previously published and distributed, no comments or change requests have been received
  - The minutes of the meeting were passed as a true representation
    - Proposed: W D Thomas Seconded: A M Simpson
5. Matters Arising
  - No matters were raised
6. Presentations & Questions from the Public
  - Questions received in the street from P Harding
    - It was stated that both Hook and Llangwm CC official notices on Facebook are accompanied by the poster's name. Why does FCC not do this?
      - The clerk explained the Hook Community Council uses a Facebook group to promote its activities and users post using their own Facebook profiles.
      - Both Llangwm and Freystrop Community Councils use Facebook pages to post Council notices only.
      - A Facebook page is an entity ('user') in its own right. Because all posts by FCC's page are Council posts and not related to any individual the clerk did not see any reason why the individual doing the post was required
    - Dangerous stones on the highway outside properties on Targate Road should be removed
      - The clerk has reported the issue to PCC but received no response. He commented to Councillor M J John that increasingly enquiries were receiving no acknowledgement and that efforts to trace the department dealing with the issue were taking up more time
7. County Councillor's Report
  - Pembrokeshire County Councillor M J John update
    - A South West Wales Regional transport plan agreed. Councillor M J John is on the scrutiny committee
    - Councillor W D Thomas asked if any communities were providing free community transport. Various schemes were discussed
    - The current Avian flu outbreak has a 3km exclusion zone and a 10km surveillance zone. Freystrop is in surveillance zone
    - PCC staff have been commended for overnight work during the extreme weather recently
    - The Commissioning team for Carer's have received an award for services
    - Rate relief is available for businesses
    - 20mph review no update
    - Secondary school places registration open
    - Questions can be raised with full Council of PCC or committees. Live streaming is available for all meetings
8. Community
  - St David's Day Community Celebration Fund
    - Grants are available to fund projects either side of 1 March 2026
    - Applications close on 17 November
9. Highways & Rights of Way
  - Moorland Road potholes
    - PCC have made more permanent repairs to the problem outside Highleys. Highways have been thanked for their prompt attention
  - Councillor W D Thomas will report a new pot hole at Middle Hill

- Complaints procedure approval request

- Multi-location Meetings
  - There is no direct funding available. The Chair thought an approximate cost of £600 should cover a system
  - The Chair was given permission to pursue the project
    - Proposed: W D Thomas Seconded: T F Holder
- Ministerial Statement on Pembrokeshire Community Boundary Review
  - The community councils of Hook, Llangwm and Freystrop will not be merged into 1 council from May 2027. All 3 will continue with no change
  - The boundary for Freystrop Community Council will be extended to include the static caravans at Upper Sandywells which are currently within the Merlins Bridge. The house at Stumpy Corner will be returned to the area having been moved to Hook Community Council at the previous review
- Councillor vacancy
  - The Notice of Casual Vacancy has been published following the resignation of Councillor D S Harries
- Clerk vacancy
  - The clerk has tendered notice of resignation and will leave the post on 30 November

- Councillors attended an informal discussion about Community Benefits, should the project proceed, with Qair on 22 October 2025
- Councillors had an open meeting with members of the public on 3 November 2025
- Correspondence received from A Brown was forwarded to Councillors upon receipt
  - A Brown read his correspondence for the benefit of those present
  - The Chair is awaiting permission to publish information received from his advisors on the responsibilities and correct process that Freystrop Community Council has to follow. A Brown disputed this stating that the processes are all available on Welsh Government websites
  - The Chair will proceed along the guidelines he has received. Members of the public may pass comments to FCC for inclusion in any response. A draft response will be written
  - An extraordinary meeting will be called once the planning application is submitted to Welsh Government
- Guidance from PEDW
  - Until planning submitted anything received will be forwarded to the developer
  - The Chair encouraged all to comment individually and copy those comments to FCC
- The correct procedure is to be followed for maximum effect



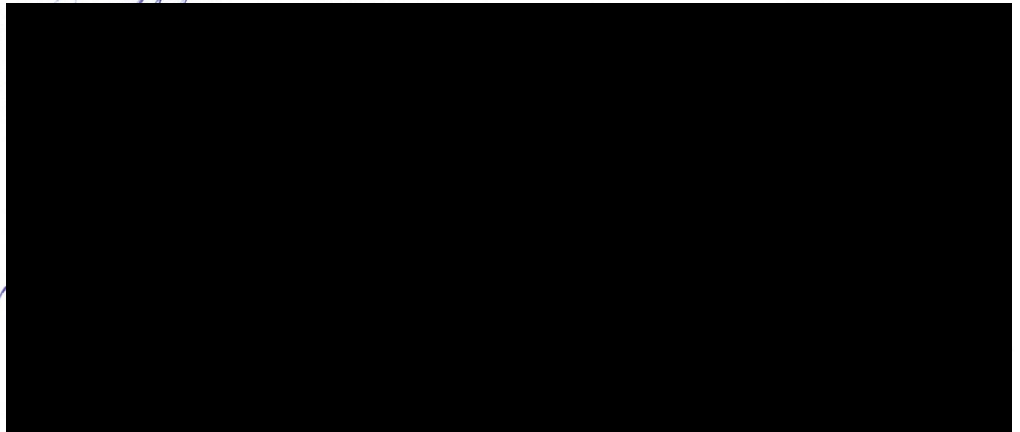

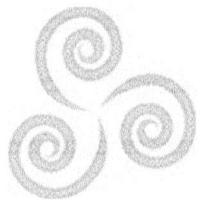
